## PREPARATION INSTRUCTIONS FOR BED BUG INSECTICIDAL APPLICATIONS

1. Kitchen and pantry areas... Remove all food and utensils from the cabinets and storage areas. Remove all items from countertops. Discard all cardboard boxes and plastic grocery bags. Pack all items into black plastic bags.
2. Bathroom areas... Remove all items from cabinets and storage areas and pack in black plastic bags.
3. Bedroom areas... Remove all bed sheets and covers and place into black plastic bags. Remove dresser drawers and place all contents into black plastic bags. Remove all clothing from closets and place into black plastic bags. All drawers and closets must be cleared and available for treatment.
4. All clothing, bed sheets, pillows, bed coverings, and towels, and wash clothes must be placed into dryers for 60 minutes of drying. Washing is not required. If clothing is not safe to be dried, it must be dry-cleaned. Once these items have been heated or dry-cleaned, they must be placed into white plastic bags. This change from black to white plastic bags is meant to enable you to identify which items have been treated and are "debugged" and ready for use.
5. Thoroughly vacuum and or mop all floor areas. Discard vacuum contents in a sealed plastic trash bag. Once again, DISCARD ALL CARDBOARD AND CORRUGATED PACKAGING.
6. All mattresses must be measured and covered with a bedbug resistant cover after treatment is rendered.
7. There will be a second treatment/ inspection in one week and a third treatment/inspection in three weeks. You may remove all items from the white plastic bags after the one week follow-up if no further infestation is noted. Your technician will instruct you on the status of your progress.
8. Autos of infested clients must be treated. Pets must be treated by the client with proper shampooing or veterinarian service.
9. Clients and pets must be out of the treated areas until the chemical is dry to the touch. Usually about 4 hours.
10. Client's pets must be out for second and third treatments as well.
